Granskningen har haft den omfattning och inriktning samt givit det resultat som redovisas i bilagan "Grundläggande granskning".

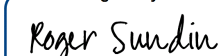

Electronic Record and Signature Disclosure

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, KPMG AB (we, us or Company) may be required by law to provide to you certain written notices or disclosures.
